President's Message

With the New Year the state's budgeting process begins. The first proposal is the governors then the legislators, department of finance (DOF) and the legislative analyst office (LAO) will issue their thoughts on the budget. In May there will be a revised budget which may or may not be finalized by June 30, the end of the fiscal year. In the meantime districts are planning and finalizing budgets based on these proposals.

This year the governor has release his budget to include \$4.5 billion dollar increase in the local control funding formula. For the 2014-15 school year that is a 10.9 percent increase. The governor also proposes to introduce legislation to create continuous appropriations for that funding.

The future may hold that the funding of our schools may finally reach a level of stability that is guaranteed. With all of the other changes and hurdles that we have been place before us, this would be one less item to distract us from our goal of providing the best educational opportunities for our students.

Committee Report: Negotiations Update

As you all know, in September our remaining furlough days were restored which returned us to a 184 day work year, along with the restoration of the remaining three-fourths of the year step increase and a .5% increase in the salary scale.

In addition, payment for class-splitting and period subbing has now been reinstated (effective January 6) with the per diem rates being adjusted to reflect the revised salary schedule. This agreement was board approved on November 4, 2013. With the restoration comes the return of our over contract hours to 30 hours per year in accordance with Article 13, B-i, p. 33.

Our survey indicated that class splitting was an important issue for a large number of our members, and therefore was a priority for our Negotiations Team.
